# *FGI / River Hills Golf Membership*

## Membership Agreement

- FGI / River Hills Golf Club Memberships include privileges beginning on date of contract until formal termination by either party.
- FGI / River Hills Golf Club reserves the right to revoke or deny any membership at any time.
- Membership dues and/or playing fees may increase at the discretion of the club.
- Proper golf attire is required.
- Members may book starting times one week in advance. Starting times may be booked in the Golf Shop or by calling (843) 399-2100.
- Playing fees will be \$20 + tax for 18-holes and \$12 + tax for 9-holes. (Restrictions may apply for 9-hole rounds.)
- Members may walk after noon at no charge. Member walking in the morning will be \$12 + tax for 18-holes and \$8 + tax for 9-holes.
- Each member may have up to three accompanied guests play for the "Guest of Member" rate.
- Guests of members are welcome to use the facility up to 6 times per calendar year. Guests must be accompanied by the member.
- Members that fail to show up for, or properly cancel their tee times are subject to be charged the full value of the starting time.
- Club Membership includes an Honors Club Card and all its privileges. (Does not qualify for purchase gift card.)
- Discontinued Club Memberships may rejoin but will have no priority on the waiting list and must pay the initiation fee again.
- Medical disruptions that result in the inability to use golf privileges may allow for a transfer to social membership status for a period of 2-6 months without a transfer fee.
- Members receive a 20% discount on non-sale soft goods and 10% discount on non-sale hard goods in the Golf Shop.
- Members receive a 20% discount in the grill (excluding alcohol, tobacco, special events, and daily specials.)
- For information regarding upgrades and transfers, please contact your General Manager.
